

Instructions for Applying for Vietnam eVisa

eVisa Application Link: Directly apply for an e-visa by accessing the link administered by the Immigration Department, Ministry of Public Security of Viet Nam <https://evisa.xuatnhapcanh.gov.vn>.

Whether you are only participating in the main program starting in Siem Reap and ending in Ho Chi Minh City or you have added the Hanoi and Halong Bay post-trip extension, you only need a single-entry visa. However, if you are transiting through another airport, within Vietnam on your way to Siem Reap, and must leave the secure area to connect with your flight to Siem Reap, you will need a multi-entry visa.

General:

Vietnamese visa is a kind of travel documents granted by Vietnamese competent authorities, providing permission to travel to and enter Vietnam.

An electronic visa (E-visa) is one of visa types issued to foreigners by Vietnamese Immigration Department via electronic system. Vietnam E-visa is valid for maximum of 30 days, single entry.

Outside Vietnam foreigners who want to enter Vietnam can [personally apply for E-visa](#) or through the inviting/guaranteeing agencies and organizations.

E-visa fee is paid via electronic payment gateway as prescribed by the Immigration Department. The fee will not be refunded if the application is refused.

[Conditions for being granted e-visa:](#)

- Outside Vietnam foreigners;
- Holding valid passport;
- Not falling into the cases of suspension from entry prescribed in Article 21 of Law on foreigners' entry into, exit from, transit through, residence in Vietnam.

E-visa holders in Vietnam may be considered to get new visa if being invited/guaranteed by authority/organization/individual in Vietnam in accordance with Law on foreigners' entry into, exit from, transit through, residence in Vietnam.

Foreigners who entry Vietnam must comply with Vietnamese law.

Inviting/guaranteeing foreigners in accordance with section 1, Article 16, Law on foreigners' entry into, exit from, transit through, residence in Vietnam; can be applied through electronic system (click [here](#)).

Notice: Foreigners falling into the cases prescribed in Clauses 1, 2, 3 and 4, Article 8 of the Law on foreigners' entry into, exit from, transit through and residence in Vietnam, shall not apply for e-visa on this Website. They should send visa applications via the inviting or guaranteeing agencies and organizations to the competent agency of the Ministry of Foreign Affairs. ([Click for detail](#))



Step 2: Pay E-visa fee. Your application will be processed in 3 working days;

- \$25/single-entry electronic visa
- \$50/multiple-entry electronic visa

Step 3: Enter registration code, registration email and date of birth to check result in [E-visa search menu](#). If being approved for E-visa, please print E-visa to enter/exit Vietnam.

Review application form

On this page you will need to upload a face photo as well as a photo of the information page of your passport. For the Face Photo, we suggest taking a photo using an app on your cell phone designed for this purpose. Here is a link to a website, which suggests several options, several of which are free: <https://ams-photo-software.com/business/best-passport-photo-apps.php>

Although it doesn't seem to specify a specific file type, we used .jpg and that file type was accepted.

While there don't seem to be any tricky fields, the following should help in completing this page:

- All required fields are denoted by red asterisks.
- Date fields are in DD/MM/YYYY format.
- The "Religion" field is required. If you don't have a designated religion, "None" works in that field.
- Select a Single-entry Visa if you're exclusively arriving in Vietnam for the Brand g Program, and a Multiple-Entry Visa if you're stopping in Vietnam before the Brand g Program that begins in Cambodia. If you're on the post-program extension in Hanoi and Ha Long Bay, you can still apply for a single-entry visa as we'll remain in Vietnam for that post-trip program.
- Grant Evisa Valid from (DD/MM/YYYY):
 - If arriving to Vietnam by air before our program, you may enter the exact date of your flight arrival, or you may choose to enter the day prior, just to give yourself a wider window.
 - If your first entry to Vietnam will be during our River Cruise at the Mekong River crossing from Cambodia to Vietnam, you should use November 6, 2024, which is the day prior to the actual border crossing. Again, this just provides a wider window, just in case.
- Under the final section Information About the Trip:

- Intended length of stay in Viet Nam (Number of Days) can be 7 if you're not extending the Brand g Program, or 11 if you're doing the Hanoi and Ha Long Bay add on, or the appropriate number based on your post-trip departure arrangements. (Note, these day numbers add 1 to allow for a buffer).
- Allowed to entry through checkpoint:
 - For the Mekong River entry during the cruise, choose Song Tien Landport.
- Exit through checkpoint:
 - If you're not adding the Hanoi and Ha Long Bay post trip extension, the exit through checkpoint will be Tan Son Nhat Int Airport (Ho Chi Minh city), unless you plan to extend in Vietnam and depart from another city.
 - If participating in the Hanoi and Ha Long Bay post-trip extension, choose Noi Bai Int Airport (Ha Noi).
- For the intended temporary residential address in Viet Nam, enter the address for the Reverie Saigon, our last hotel: 22-36 Đ. Nguyễn Huệ, Bến Nghé, Quận 1, Hồ Chí Minh, Vietnam.
 - The City/Province should be: Ho Chi Minh City.
- Be sure you've checked the box next to the statement "I assure that I have truthfully declared all relevant details".
- Your final step will be to fill in the Captcha and click Review Application Form.

After successfully submitting the form, you should receive a box similar to the below:



The next screen should recap all the information you entered and at the very bottom of the webpage there is a Payment Button to click on.

Once you've clicked the payment button you'll be presented with another confirmation page. We would suggest printing this page for your records.

Two boxes should be checked at the bottom of this page:

- Pay E-visa Fee at VietCombank payment gateway (accepted by Vietnam Immigration Department)
- I agree

Next click Pay eVisa Fee, then you'll be presented with another screen asking if you wish to pay by ATM Card or Credit Card. Click on the one you prefer, and you'll be presented with options to choose from.

After you enter your payment details, you will be presented with the following page:

Visa is an **IMPORTANT PROCEDURE IN THE IMMIGRATION PROCESS**, you need to carefully check the application information before submitting and note the following regulations:

Notice: Registration code will be sent via your registered email, therefore, please kindly provide the correct email, and take full responsibility for the provided information.

1. According to regulations, your e-Visa result will **NOT BE PROVIDED VIA EMAIL**. To check your e-Visa result, follow these steps:

- Step 1: Visit the page: https://evisa.xuatnhapcanh.gov.vn/en_US/tra-cuu-ho-so
- Step 2: Provide the required information, including registration code, email and date of birth to check.
- Step 3: Download, print out your e-Visa and bring it along your entry.

2. According to **Article 5 at Resolution 30/2016/QH14** of the Socialist Republic of Vietnam, the e-Visa fee once submitted is **NON-REFUNDABLE BY ANY REASONS** as the fee is for processing of the application and is **NOT DEPENDENT ON EITHER GRANTING OR REJECTION** of visa.

3. The e-Visa fee payment status update **MAY TAKE UP TO 2 HOURS** due to technical reasons/network delays. You need to check your **APPLICATION RESULT** and **PAYMENT RESULT** (according to section 1) before **RE-APPLYING**. If you submit and pay for **THE SECOND APPLICATION**, which is the same as the previous application, **THE IMMIGRATION DEPARTMENT WILL PRESUME THAT THESE ARE TWO DIFFERENT APPLICATIONS** and that the previous fee will **NOT BE REFUNDED**. If both applications are granted a Visa, they are equal use.

4. If your information is not sufficient and valid, you will be requested to provide further information or you can be rejected based on the policy of the Vietnam Immigration Department. When you have to provide the information again, the processing time will be started when you resubmit the **VALID** information. In this case, take note of the time of entry.

5. The e-Visa is normally processed within 03 working days (*) after the e-Visa fee has been paid with sufficient and valid information.

6. In case of the application to be further verified by **The Ministry of Public Security**, you will receive the result from 03 to 15 working days (*)

(*) The working days exclude the weekend and national public holidays.

[Read this page carefully and you may even want to print it for your records. You will note that the visa will not be emailed to you, you need to log back in at the address provided in Step 1 and provide the required information in order to download and print your visa.](#)

After you click “I agree”, you will be brought back to the payment screen, where you will need to click “Continue” to process the payment.

You should then receive a screen which indicates “Payment Success”!

Finally, you should receive an email confirmation confirming the payment and again providing the web address, where you’ll need to return to download and print your visa.
